126. PROBABLE CAUSE STATEMENT

On 10/08/2021 at approximately 12:51 hours, Prebble Quinn Ramswell, D.O.B 11/18/1971 violated F.S.S 933.15 Obstruction of service or execution of search warrant and F.S.S 784.07 Battery of law enforcement officer. The details are as follows:

Investigators from the Office of State Attorney with the assistance of the Okaloosa County Sheriff's Office, see OCSO21CAD207469, arrived at 14 Country Club Dr. E, Destin, FL 32541 to execute a lawful search warrant signed by Okaloosa Circuit Judge Stone. Investigators knocked on the door which was answered by witness Anthony Ramswell. Investigator T. Wells spoke to Mr. Ramswell and informed him we had a search warrant for his residence. Mr. Ramswell denied entry, and I, Investigator Forehand verbally identified myself as Police and stated we had search warrant for the residence. Mr. Ramswell again denied entry, physically blocking entry into his residence with his body. As we attempted to walk past Mr. Ramswell to secure the residence Mr. Ramswell physically obstructed our path. Warnings were given however Mr. Ramswell chose not to comply and was detained at which time he resisted efforts by Investigator Wells and Investigator Forehand. Mr. Ramswell was placed into cuffs and obtained a small laceration to his forehead during the process. Mr. Ramswell was kept in the foyer of the residence.

Investigator Wells and Investigator E. Somrude cleared the residence. Investigator Wells located Suspect Prebble Ramswell in the back yard and asked her to step inside. Once inside Investigator Wells attempted to keep S/ Prebble Ramswell near the back door to read her the search warrant, however she would not comply and made her way to the foyer with her husband. During this process Investigator Wells made many attempts to calm down S/Prebble Ramswell with negative results. Once she was in the foyer, Investigator Wells attempted to continue to read the Search warrant to her. S/Prebble Ramswell continued to over talk Investigator Wells and escalating her anger. Investigator Forehand advised S/Prebble Ramswell if she could not calm down she would be detained for Officer Safety. Investigator Wells continued to read the search warrant to her. While he was reading Investigator Forehand noticed a small amount of blood on W/ Ramswell's forehead and pulled his camera out to document the injury, to which w/Ramswell turned his head away from the camera. Investigator Forehand told W/Ramswell he had blood on his forehead and needed to document injury.

S/Prebble Ramswell became extremely agitated and pushed by Investigator Wells towards her husband. Investigator Forehand attempted to calm her down and asked

her to have a seat. S/Prebble Ramswell refused several orders and was extremely belligerent. Due to her continual escalation Investigator Forehand attempted to detain S/Prebble Ramswell however she physically resisted. Investigator Forehand had to use physical force to attempt to get her to put her arms behind her back when she would not comply. S/Prebble Ramswell ended up in the standing position with her chest pressed down on the steps while all three investigators had to physically gain compliance with her to get her arms behind her and cuffed. During this altercation Investigator Forehand was behind S/Prebble Ramswell when she used her right leg and foot to horse kick Investigator Forehand. S/Prebble Ramswell's right foot made contact with Investigator Forehand's lower back and rear end. Investigator Forehand verbally acknowledged to her that she just kicked him. Compliance was eventually obtained and S/Prebble Ramswell was hand cuffed with arms behind her. S/Prebble Ramswell was seated on the steps, encouraged to calm down while Investigator Wells continued to read the search warrant.

S/Prebble was arrested and transported to Okaloosa County Jail by OCSO Dep Watts who had no further involvement. This incident was captured on OCSO LT. Parkton agency issued body camera and saved the above OCSO CAD number.

No other injuries were reported.
